Greetings from the Executive Director....

Dear Friends & Colleagues:

We are looking forward to providing non-personal, durable medical equipment to meet your needs as we have for the last one hundred and sixteen years. Your generosity is what makes all of this possible because your donations, bequests, and memorials are the only source of income for the Assistance Fund. You have always done a fantastic job of supplementing through your participation in our annual raffle. Tickets for the 2013 Assistance Fund Raffle will be available for sale from March 1st through the day of the raffle drawing, April 18th. The funds we raise from the sale of raffle tickets can only be used to purchase medical equipment. Put another way - **When you purchase raffle tickets, you are purchasing medical equipment.** In 2012, you purchased \$21,700 worth of medical equipment.

We currently have 1,825 pieces of medical equipment checked out to 859 DPS families, with another 620 pieces available in our inventory. In addition, the Assistance Fund also provides up to \$250 toward the rental or purchase of certain larger pieces of equipment that we are not able to stock. Please call us anytime to see if your medical equipment needs can be met through the Assistance Fund.
