Our volunteers save the Club an average of \$25,000 each year through their hard work and dedication. We could not provide the quality services you have come to expect without their help. Please be sure to thank them whenever you have a chance.

The DPS Supplemental Benefits Program

As an employee or retiree of the DPS, you are eligible for benefits from the DPS Supplemental Benefits Program. We are the oldest non-profit in Colorado, founded in 1897 by William Smiley, Dora Moore, and several other DPS pioneers. Our services are two-fold:

Through our **Assistance Fund**, we provide all active and retired DPS employees and their family members free use of durable medical equipment. Contact our office and let us know what you need and then come by and pick it up. We provide almost everything you might possibly need, including but not limited to walkers and wheelchairs, bath and toilet accessories, bed rails and bed tables, canes, crutches, and mobility items like knee rollators. We currently have 2004 pieces of equipment checked out to 893 families, and 584 pieces in stock. This inventory includes approximately \$10,000 in new inventory just purchased this year from Ocelco Patient Aid Equipment.

As a current full-time employee, the **Payroll Protection Plan** provides you with cash payments for days you miss from work due to personal illness or injury. Currently we pay our members \$50 a day for every day missed over the 10 or 12 sick days you are provided by the district each year. Benefits are graduated depending on your membership year, increasing by 5-day increments with every year of membership through your 5th year. In your 6th year you are fully vested and are eligible to receive up to 100 days of benefits (\$5,000) in any given year from this point forward, not to exceed 200 days in any 5-year period. Our membership year runs from July 1st through June 30th. Membership costs you just \$10.00 per month through payroll deductions. Open Enrollment is in May and September of each year. Be sure to contact your Representative with any questions, or call the DPS Supplemental Benefit Program at 303-377-0222.

ARE YOU RETIRING THIS YEAR?

Congratulations and **thank you** for your many years of service to the children of Denver. As a retiree, you maintain your privileges with the **ASSISTANCE FUND**. You may continue to borrow durable, non-personal medical equipment from us for yourself or any person in your immediate family for as long as you need it, **free of charge**. **The equipment is available to all active and retired employees of the DPS.**

To be added to our retiree list and to ensure your continued eligibility to borrow equipment, you must complete the **DPS Retiree Continuation Data Form** below and mail it to our office at 990 Glencoe St, Denver CO 80220. The form is also available in PDF format for you to download from our website – www.dpssbp.org.

You do not need to use all your accumulated sick leave in order to receive these benefits, nor does your participation in any other program prevent you from receiving these benefits.

The membership/claim year begins July 1st and ends June 30th.
